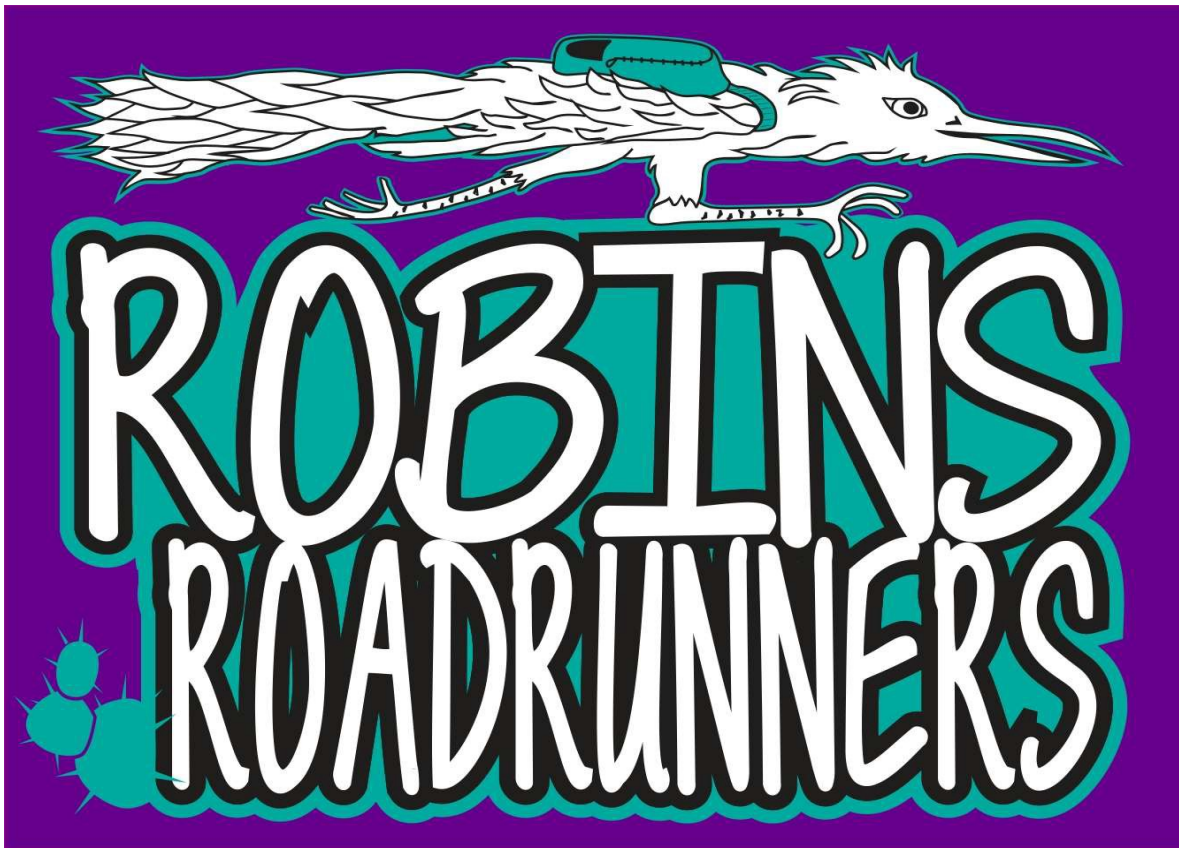

Robins K8 provides opportunities for parent-teacher conferences sharing information and participating in their child's program with timely staff response to academic suggestions. Parents provide assistance in understanding goals, assessments, monitoring and decision making to coordinate and participate in their child's education.
